## TERMS AND CONDITIONS

In the event of a dispute, the reasonable interpretation and determination by the Board of TCRC, INC., the raffle licensee, is final and binding. This raffle is void where prohibited by law. The raffle is subject to all applicable federal, state, and local laws, ordinances, and regulations. Any and all applicable federal, state, and local taxes and all fees and expenses related to winning a prize are the sole responsibility of the winner.
